




Funding Updates

23-24 School Year Payment Process for SUFS FES-EO and FTC Providers



Remittance Reports



Schools will receive two remittances via email. The first remittance, which they receive, is a notification that money is on the way. This notification is from **Tipalti** and does not contain any student details. (Received the day SUFS makes the payment)

The second remittance will come from **Epicor** during the payment posting process. The remittances generated from **Epicor** will include the student's details.

(Received approx. 72 hours from when SUFS makes the payment)

Note: Both remittances will be sent from <u>APReports@sufs.org</u>. Contact your Step Up Regional Manager if you still need assistance.

Funding Timelines – Q2

- Student Enrollment Deadline: October 1, 2023. This list is sent to the FLDOE by the SFO.
- FLDOE send funds to SFO: November 1, 2023.
- SFO reconciles and sends funds to individual student accounts within 14 business days of receipt of funds.
 - Survey of EO parents to be sure they are still in the private school.
- Once student is Funded, an Invoice is created and shows for the school in EMA for approval.
- Q2 Payments should be made to schools between November 15-December 1st.
- SUFS pays weekly. Approved Invoices by Friday will receive funds by following Friday.
- Payment takes 3-5 days for ACH transfer once initiated.
- <u>NOTE:</u> Students not funded in Q1 should be included in your Q2 payment. This should also result in two separate Invoices to approve.

Funding Timelines – Q3

- Student Enrollment Deadline: January 1, 2024. This list is sent to the FLDOE by the SFO.
- FLDOE send funds to SFO: February 1, 2024.
- SFO reconciles and sends funds to individual student accounts within 14 business days of receipt of funds.
 - Survey of EO parents to be sure they are still in the private school.
- Once student is Funded, an Invoice is created and shows for the school in EMA for approval.
- Q3 Payments should be made to schools between February 21st March 6th.
- SUFS pays weekly. Approved Invoices by Friday will receive funds by following Friday.
- Payment takes 3-5 days for ACH transfer once initiated.

Funding Timelines – Q4

- Student Enrollment Deadline: March 1, 2024. This list is sent to the FLDOE by the SFO.
- FLDOE send funds to SFO: April 1, 2024.
- SFO reconciles and sends funds to individual student accounts within 14 business days of receipt of funds.
 - Survey of EO parents to be sure they are still in the private school.
- Once student is Funded, an Invoice is created and shows for the school in EMA for approval.
- Q4 Payments should be made to schools between April 22nd May 6th.
- SUFS pays <u>weekly</u>. Approved Invoices by Friday will receive funds by following Friday.
- Payment takes 3-5 days for ACH transfer once initiated.
- Payment deposited to schools and providers on a weekly basis.

Scholarships for Florida Schoolchildren



Dear School Administrator,

Based on our calculations, your school will receive more than \$250,000 in scholarship dollars from the Florida Tax Credit Scholarship, the Family Empowerment Scholarship for Educational Options, the Family Empowerment Scholarship for Students with Unique Abilities, the Hope Scholarship or in aggregate scholarship dollars from multiple programs for the 2022-23 school year.

Per Florida statute 1002.421(1)(q), your school <u>must</u> contract with a currently licensed Florida Certified Public Accountant (CPA) with a firm licensed to perform attest engagements to conduct a set of Agreed Upon Procedures (AUP), regarding your usage of those funds. The Agreed Upon Procedures Report must be received on or before September 15, 2023.

Failure to meet this deadline could result in the loss of eligibility to participate in scholarship programs. This email will serve as a 30-day notice.

Who is required to complete an AUP?

Private schools receiving more than \$250,000 in scholarship dollars from the Florida Tax Credit Scholarship, the John M. McKay Scholarship for Students with Disabilities, the Hope Scholarship, the Family Empowerment Scholarship or in aggregate scholarship dollars from multiple programs and/or multiple SFOs in a single academic year must submit a financial report to Step Up For Students (or the scholarship funding organization from whom they receive most scholarship funds) no later than September 15th of the following year (i.e., for the 2022-23 school year, reports will be due by September 15, 2023).

Agreed Upon Procedures are required by ss. 1002.395(6)(o) and 1002.421(1)(q), F. S..




