# **QUALIFYING AND APPLYING FOR A SCHOLARSHIP**

## **Application Deadlines**

#### Added:

• Renewal students who miss the April 30 application deadline or the May 31 accept/decline deadline will be treated as new applicants

## **Proof of Residency (POR)**

#### Added:

Residential internet bill as acceptable POR document

# **AUTHORIZED USES OF SCHOLARSHIP FUNDS**

#### Added:

• Link to FLDOE's eligible postsecondary institution web page

# **GENERAL PURCHASING PROVISIONS**

#### Added:

• The Educational Benefit Form requirement

#### **Clarified:**

• Policy prohibiting receiving payments, refunds, or rebates of scholarship funds

# **SCHOLARSHIP PARTICIPATION REQUIREMENTS**

#### **Removed:**

• References to the Florida School For Competitive Academics, as it no longer exists



# **FUNDING FOR SCHOLARSHIPS**

## **Scholarship Funding Schedule**

#### Added:

• Messaging that it is the responsibility of the parent or guardian to approve any eligible invoices in EMA

## **Funding Continuation and Rollover**

#### Added:

• Information about scholarship account maximum balances allowed by law

## **Accrued Interest**

#### Added:

• Description of when accrued interest is deposited into student accounts

### **Reimbursement Timing**

#### Added:

• Information about fees that are eligible to be paid to a private school or HEIP program before the school year paid for begins

# **DOCUMENTING ELIGIBLE USES**

## **Required Supporting Documentation**

#### Added:

Information for private school tuition using tuition management systems

## **Physical Education (P.E.)**

#### **Removed:**

• Requirement that student's name and instructor's name be included on an invoice or receipt

## **FLDOE Approved Pre-Apprenticeship Program**

#### Added:

Link to FLDOE Pre-Apprenticeship Program web page

## **Documentation of Credentials**

#### Added:

- Credentials must be provided in English for Part-Time Tutoring and Choice Navigator services
- Full LinkedIn profile may be used to verify provider employment history



# **REIMBURSEMENT TIMING**

• Included post-secondary institutions and dual enrollment as eligible for advance reimbursements

## **Eligible Reimbursements for Advance Services**

#### Added:

• Parents and guardians can apply for reimbursement for services up to four months in advance.

# **MYSCHOLARSHOP**

• Removed MSS Status definitions, as they will be changing

# **PRE-AUTHORIZATION REQUESTS**

#### Added:

- Parents and guardians should allow up to sixty (60) days for pre-authorization requests to be reviewed and processed after all required documentation has been submitted.
- Deadline to submit pre-authorization requests of May 29, 2026
